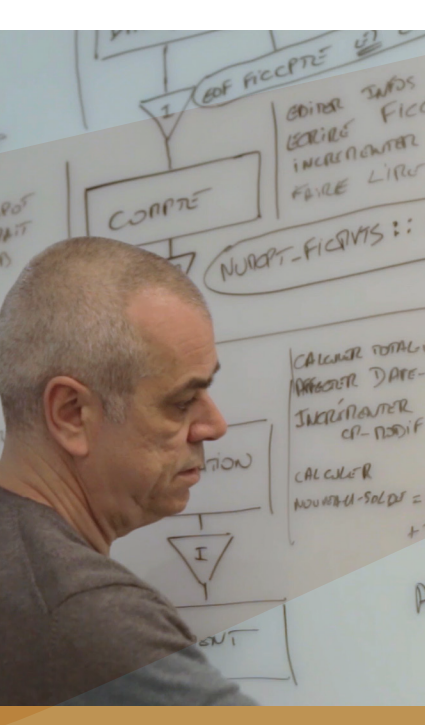

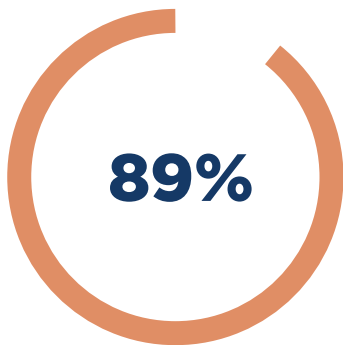

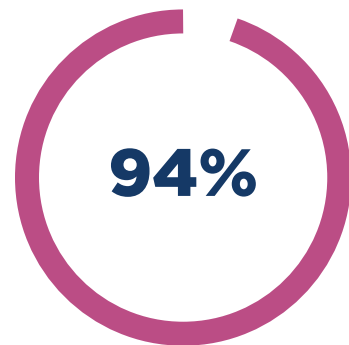

GENERAL SALES CONDITIONS

PURPOSE AND SCOPE OF APPLICATION

Any order for training implies the Customer's unreserved acceptance of and full and complete adherence to these general terms and conditions of sale, which prevail over any other document of the Customer, and in particular over any general terms and conditions of purchase.

CONTRACTUAL DOCUMENTS

All orders must be made in writing. INTM will send the Client a registration form. The latter may return it signed for approval or send a company order form. The invoice sent will take the place of a simplified training agreement. At the client's request, an agreement can be established. The client undertakes to return a signed copy to INTM as soon as possible, bearing his commercial stamp.

FINANCIAL CONDITIONS, PRICES AND PAYMENT

A commercial and financial proposal will be established by INTM beforehand. A deposit of 30% will be paid at the time of order. The remainder is due upon receipt of the various invoices issued as the training courses progress.

All our prices are indicated in euros and exclusive of tax. They are to be increased by the VAT at the current rate. Any training course started is due in full. INTM establishes a final invoice on the last day of the training. The client undertakes to pay within thirty days of the date of the invoice, except for clients outside France for whom prepayment will be required fifteen days before the start of the training (INTM reserves the right to refuse to accept a participant in the absence of payment prior to the training), and unless otherwise stipulated in the special conditions.

Furthermore, with regard to any new Client, in the event of default or delay by a Client in the payment of a previous invoice, with regard to a Client company with less than 50 employees, or a private client financing his training alone, INTM reserves the right to demand a prepayment.

Any sum not paid on the due date will give rise to the payment by the Client of late penalties at the interest rate applied by the European Central Bank to its most recent refinancing operation plus 10 percentage points. These penalties shall be payable by operation of law, upon receipt of the notice informing the Customer that they have been charged. In addition to the penalties for late payment, the Client will be liable to pay a fixed indemnity of 40€ for col-

lection costs in accordance with articles L441-6 c. com. and D. 441-5 c. com. However, INTM reserves the right to claim additional compensation, upon justification, when the costs actually incurred are higher than this amount.

In the event of non-payment of an invoice that has fallen due, after formal notice has remained without effect for 5 working days, INTM reserves the right to suspend all current and / or future training.

MODALITIES OF ORGANIZATION AND REALIZATION OF THE TRAININGS

Acceptance of the program

Any order of training supposes that the customer accepts the program present on the site at the date of his order.

Convocation

Two weeks before the start of your training, you will receive an invitation with the location and times.

Replacement of a participant

INTM offers the Client the possibility of replacing a participant without additional billing until the opening of the training session concerned. Any request for replacement must be made in writing.

CANCELLATION AND POSTPONEMENT CONDITIONS BY THE CUSTOMER

1. Any cancellation by the Client must be communicated in writing. For any cancellation less than fourteen clear days before the start of the course, 50% of the training fee will be immediately payable as a lump sum. However, the Client is offered the possibility of postponing the course within six months and the compensation will be allocated to the cost of this new session decided by mutual agreement between INTM and the Client. For any cancellation, less than seven clear days before the beginning of the course, the total amount of the training will be due.

2. Cancellation and postponement conditions for training courses held at INTM

Any cancellation by the Client must be communicated in writing. For any cancellation less than fourteen clear days before the start of the training session, 50% of the amount of the training session will remain immediately payable as a lump sum. However, the Client is offered the possibility of a postponement within three months and the compensation will be allocated to the cost of this new session decided by mutual agreement between INTM and the Client.

3. Condition of cancellation by INTM

INTM reserves the right to cancel any training course at the latest one week before the scheduled date, in the event of an external event (lack of participants, problems with the supply of course materials, illness of the trainer, interruptions of services in the event of labor disputes, weather conditions, etc.), without compensation or penalty to the client. The Client will be able to choose another date in the training calendar or cancel his registration without penalty. INTM cannot be held responsible for any costs incurred by the Client or damages resulting from the cancellation of a training course or its postponement to a later date.

CERTIFICATIONS

If one or more certification exams are included in the training offer, these exams will only be available to the participant after the full payment of the training. These exams can be taken at the latest one year after the last day of the training.

PAYMENT BY AN OPCO

If the Client wishes the payment to be issued by the OPCO on which he depends, it is their responsibility to:

- make a request for payment before the beginning of the training and to make sure that this request is properly completed.
- indicate this explicitly on the registration form or on the order form.
- make sure that the payment is completed by the OPCO that they will have designated. If the OPCO only partially covers the cost of the training, the remainder will be invoiced to the Client. If INTM has not received payment from the OPCO by the 1st day of the training, the Client will be invoiced for the full cost of the course. In case of non-payment by the OPCO, for any reason whatsoever, the Customer will be liable

for the full cost of the training and will be invoiced for the corresponding amount.

ORDER REFUSAL

In the event that a Client places an order with INTM without having paid for the previous order(s), INTM may refuse to honor the order or deliver the training courses concerned, without the Client being able to claim any compensation, for whatever reason.

DATA PROCESSING AND FREEDOM

The Client is informed that personal information communicated to INTM in application and execution of orders and/or sales may be communicated to INTM's contractual partners for the purposes of said orders. In accordance with the law n°78-17 of January 6, 1978, known as the «Loi Informatique et Libertés» updated by the law of August 6, 2004, the Client has a right of access, rectification and opposition to personal data concerning him. This right can be exercised by making a request by e-mail or by mail addressed to INTM.

COMMUNICATION

The Client authorizes INTM to mention its name and logo and to mention as references the subscription to an order and any operation resulting from its application in all their commercial documents.

WAIVER

The fact that INTM does not avail itself at a given time of any of the clauses of the present document cannot be considered a waiver of the right to avail itself of these same clauses at a later date.

APPLICABLE LAW

The General Conditions are governed by French law. Before all, a friendly solution will be sought. Failing that, the settlement of the dispute will be brought before the competent court.

ASSIGNMENT OF COMPETENCES

Any dispute that cannot be settled amicably will be under the EXCLUSIVE COMPETENCE OF THE COMMERCIAL TRIBUNAL OF NANTERRE, whatever the nature of the dispute, headquarters or residence of the Customer, notwithstanding multiple defendants or warranty claims. This jurisdictional clause shall not apply to any dispute arising out of or in connection with the use of the services of this website. This jurisdiction

clause shall not apply in the event of a dispute with a non-professional Customer for whom the legal rules of material and geographical jurisdiction shall apply. The present clause is stipulated in the interest of INTM, which reserves the right to waive it if it sees fit.

ELECTION OF DOMICILE

The election of domicile is made by INTM at its headquarters at 2 rue Kléber in Levallois-Perret (92300).
